BACKGROUND

In the face of COVID-19 pandemic, many people in the world have been locked down with their family. For some, it has been an opportunity for families to grow closer. For others, it has been a source of tension, as increases in divorce and domestic violence attest. Most families have been negatively affected economically. Millions of workers around the world lost their jobs because of the COVID-19 outbreak, that increased the burden on social protection systems.

The COVID-19 pandemic has exposed the urgent need for legal and social protection of the family and family-oriented policies. In the recovery period following the COVID-19 pandemic, the importance of creating an environment conducive to family formation and stability should be borne in mind, so that life within the family can be a source of consolation and renewal for all after the COVID-19 crisis.

Efforts to rebuild after COVID-19 should be carried out taking into account the importance of protection of the family and assistance by society, including the right of everyone to work and live in dignity.
